





BUILDING: Matt Ratzow, from O'Neal Construction, was onsite last Thursday to meet the automated door installer and the electrician. He also discussed the flagpole light replacement project with the electrician. The roofers have been called to troubleshoot a leak from the green roof into the Cozadd Room.

PENAL FINES: I have been in contact with Allen Wilson, our Wayne County Commissioner. The County Ways and Means Committee met regarding this issue, but our library has not received any official communications from the County.

INSTITUTE OF MUSEUM AND LIBRARY SERVICES: The IMLS is a federal program which funds statewide grants and services in Michigan. In response to an executive order by President Trump, almost all of the staff of the IMLS has been placed on leave and all processing of grants has been suspended. Through funding from the IMLS, our library's patrons have received free access to Melcat, the statewide interlibrary book loaning service, as well as a wide variety of Michigan eLibrary (MeL) databases such as:

- Learning Express (resume and cover letter assistance; GED test prep, ACT and SAT test prep, computer basics video courses, etc);
- Auto Repair Source (car repair guides);
- Search databases that provide the full-text of numerous journal and magazine articles for students of all ages, as well as for adults researching a health condition or legal matter, etc.

As a public library, we rely heavily upon the above vital resources, which are funded by Congress.

I do not yet have any information regarding a discontinuation or interruption of these services, or if libraries will be able to fund them independently of the loss of IMLS funding. MeL and MeLCat are paid for through \$3.4 million in federal funding and \$1.4 million in state funding.

ACCOUNTING SOFTWARE: Tyler Technologies will discontinue our old government accounting software, FundBalance, in December 2026. Our accountant, Sharon Duckworth, and I have been exploring three possible systems: Tyler Technologies, BS&A and Sage Intacct. A lot has changed since the last time we chose accounting software, including the price, but new software will provide us with a secure cloud-based product that will offer more flexibility and reporting functionality. I am recommending BS&A which is also used by the City of Belleville, the Canton Public Library, the Plymouth District Library, and the Orion Township Library. (Sharon Duckworth has been through a conversion to BS&A for one of her other clients).

STAFF: The library's annual staff in-service day is Friday, April 25. We have hired a trainer from the Midwest Collaborative for Library Services to hold a workshop on workplace wellbeing and resiliency. It will cover stress reduction and techniques for staff to bring out the best in themselves and others. The afternoon will feature mini-Ted

talks from staff members on a variety of topics (in homage to Fred C. Fischer, we are calling them Fred Talks). The librarians will also spend time this day in the stacks working on collection development.

PROGRAMMING: Happy National Library Week! This year's theme is "Drawn to the Library", and our library is celebrating with a few special programs including I Love My Library Storytime, a Quiet Reading Book Club Kickoff, and Dress Like a Book Character Day. April is National Poetry Month, and the library is holding a poetry contest. Winners will receive prizes and have their poetry displayed in the library. Our library is a stop on ALA President Cindy Hohl's "We All Belong" library tour which will focus on the important work of librarians and library workers. The public and the boards and staff from our library and neighboring libraries are invited to attend on Tuesday, May 6 at 9:30 am. Following her talk, she will present a children's storytime at 11 am.

MEDIA CENTER: Nikki Pickeral repainted the Sumpter Media Center's hours on the front entrance with a spring theme. A family who was driving down the road happened to see the artwork and stopped in. They happily received library cards and checked out some books for their children.







Entire staff at federal agency that funds libraries and museums put on leave

The Institute of Museum and Library Services has placed its entire staff on administrative leave.

The IMLS is a relatively small federal agency, with around 70 employees, that awards grant funding to museums and libraries across the United States.

This month, President Trump named Keith E. Sonderling — the deputy secretary of labor — the new acting director of IMLS. This followed Trump's previous executive order shrinking seven federal agencies, including the Institute of Museum and Library Services.

According to a statement from AFGE Local 3403, which represents IMLS workers, the agency's staff was notified by email about being placed on paid administrative leave for up to 90 days, after a "brief meeting between DOGE staff and IMLS leadership." Employees had to turn in government property, and email accounts were disabled.

What is the IMLS?

The IMLS is an independent federal agency that provides grants to libraries and museums across the country. According to the American Library Association, the IMLS provides "the majority of federal library funds." The IMLS says it awarded \$266 million in grants and research funding to cultural institutions last year. This money goes to help staff, fund maintenance and create new programs. In comparison, the projected 2025 budget for the National Endowment for the Arts was \$210 million.

For instance, in 2023 the IMLS funded projects such as a workforce training program, including internships, at the Museum of Discovery and Science in Florida, a pilot program in Iowa to help library staff address patrons' psychological needs and basic library functions (books, computers, internet) for various Native American tribes. You can find programs that the IMLS has funded to libraries and museums in your state through its dashboard.

According to the advocacy group EveryLibrary, public libraries are primarily funded by city and county taxes. And federal funds account for a much smaller portion of a library's budget. However, the group issued a statement following Trump's executive order, saying that "without this core federal funding for state libraries, museums, and archives, we risk losing critical programs and services in every state."

Trump wants to restore statues and monuments. Will that happen?

According to AFGE Local 3403, the status of grants that were previously awarded is unclear. And, the union statement said, without staff to administer the programs, it's likely most grants will be terminated.

Steve Potash is the CEO of OverDrive, which distributes digital products such as audiobooks, e-books and movies to libraries. He said in an interview that small and rural libraries will be most affected by cuts to federal funding.

"When a public library which has growing demand for their online and digital materials is getting any kind of budget cuts, hard decisions have to be made," said Potash.

Clarification

April 1, 2025

An earlier version of this story stated that employees of the IMLS were put on paid administrative leave for 90 days. The email they received states it is "up to" 90 days. Also, the story initially stated the Museum of Discovery and Science is in Orlando. It is in another part of Florida, Fort Lauderdale.





Joint Statement on IMLS from Michigan Libraries, Museums, and Archives

On March 14, 2025, President Trump issued an **Executive Order** (EO) that adversely affects the only federal agency that provides resources to our nation's libraries, museums, and archives. The EO "Continuing the Reduction of the Federal Bureaucracy" directs the Institute of Museum and Library Services (IMLS) to eliminate non-statutory programs and reduce its functions and personnel to the minimum required by law. For IMLS, this would mean a dramatic reduction in its scope and

capacity to support our nation's cultural institutions. Libraries and museums across the country will feel the effects of these cuts, particularly in areas reliant on discretionary funding and special initiatives.

Michigan receives modest federal funding from IMLS, but our 397 public library systems, 87 academic libraries, nearly 3,000 school libraries, 650 museums, and hundreds of historical organizations pride themselves on using these resources efficiently and innovatively to deliver outstanding programs and services. The changes to IMLS ordered in the EO would be devastating to the cultural and literary landscape enjoyed by all Michigan residents.

What is at stake if IMLS reduces its workforce and dismantles programming, funding, and services to our libraries, museums, and archives?

Close to \$2.25 million/year in individual grants to our libraries, and an additional \$1.77 million/year for our museums and archives could be affected.

In addition, the Library of Michigan may be adversely affected if the \$4.78 million Grants to States were to cease including:

- the Michigan Electronic Library (MeL and MeLCat) a centralized catalog and resource-sharing service (inter-library loan) created to lend and share materials among all types of libraries in Michigan
- · MeL databases that are used extensively by our academic and school libraries
- travel stipends for library staff to attend professional development opportunities to stay current with trends that affect the profession
- funding for cohorts on financial sustainability, digital literacy, artificial intelligence, and public library management
- excellent training and educational opportunities for all library workers through participation in Niche Academy offerings

We strongly support continued funding and staffing and implore President Trump to rescind this Executive Order. Our goal is to ensure that the IMLS continues to fund worthy and essential library, museum, and archival programs that benefit Michigan communities well into the future.

In Fiscal Year 2024, the government spent \$6.75 trillion, exceeding its revenue and resulting in a deficit. While the stated purpose of the EO is to reduce bureaucracy and waste, it is unreasonable to target the federal funding allocated to libraries and museums that represents just a tiny fraction – approximately 0.0043% in FY 2024 – of

the federal budget. This minimal investment supports institutions that are vital to education, cultural preservation, and community enrichment.

While funding for the remainder of Fiscal Year 2025 (ending Sept. 2025) has been appropriated to the IMLS in the newly approved Continuing Resolution, we have no guarantees of funding for IMLS in the Fiscal Year 2026 budget.

It is time to take a stand and speak up today by calling, writing, emailing, visiting, or sending a letter to your federal elected officials. We encourage you to use one of the links below that have been set up by various national organizations.

Contact your legislators and tell them to continue fully funding IMLS – both discretionary programs and those explicitly mandated by law. Don't forget that your communication will be stronger by adding your own words, and how this will affect you, your cultural institution, and your community.


